

KEYNOTE SPEAKERS



HANS LANDSTRÖM

holds a Chair in Business Administration, special in Entrepreneurship and Venture Finance at the Sten K. Johnson Centre for Entrepreneurship, Lund University, Sweden. He is co-founder of two large research centres at Lund University: Center for Innovation, Research and Competence in the Learning Economy (CIRCLE) which is a research centre on innovation studies, and Sten K. Johnson Centre for Entrepreneurship (SKJCE) focusing on entrepreneurship research and education. President of the European Council for Small Business (ECSB) between 1999 and 2001, and Historian within the ENT Division of the Academy of Management between 2011 and 2016. Since 2010 he is ECSB Fellow, and in 2017 he was awarded as the Wilford L. White Fellow of the International Council for Small Business (ICSB). His research interests include entrepreneurial finance, venture capital and business angels, entrepreneurial education, and the history of entrepreneurship as a research field. Author of 15 books and edited books, and his articles have been published in journals such as Research Policy, Journal of Business Venturing, Small Business Economics, Entrepreneurship Theory and Practice, Entrepreneurship and Regional Development, and Journal of Small Business Management.

LÉO-PAUL DANA

a graduate of McGill University and of HEC Montreal, is Professor at Montpellier Business School and a member of the Entrepreneurship & Innovation chair, which is part of LabEx Entrepreneurship. He has published extensively in a variety of leading journals, including the British Food Journal, CornellQuarterly, Entrepreneurship & amp; Regional Development, Entrepreneurship: Theory & Practice, Journal of Small Business Management, the Journal of World Business, and Small Business Economics. His research interests focus on cultural issues, including the internationalization of entrepreneurship and the nature of indiaenous entrepreneurship.





SILKE TEGTMEIER

is Associate Professor of Entrepreneurship at University of Southern Denmark. Currently, she is President of the European Council for Small Business and Entrepreneurship. Her research focus is on cognitive perspectives of the individual in entrepreneurship. Among others, she investigates entrepreneurial opportunities, engineering entrepreneurship education and women's entrepreneurship. Dr. Tegtmeier has published about 30 articles and 3 books, e.g., in Small Business Economics and Journal of Small Business Management. She Initiated and hosted several conferences and has experience as section head.and the nature of indigenous entrepreneurship.

SHAKER A. ZAHRA

is the Chair of the Strategic Management & Entrepreneurship Department, Robert E. Buuck Chair of Entrepreneurship and Professor of Strategy and Entrepreneurship in the Carlson School of Management at the University of Minnesota, where he is also the Academic Director of Gary S. Holmes Entrepreneurship Center. His research is widely published and cited, garnering numerous awards including the Global Award for Entrepreneurship Research and five honorary PhD degrees. He is also a Fellow of the Academy of Management and several other professional organizations.





ROBERTO PARENTE

is Full Professor of Entrepreneurship and Innovation and President of the Master Course in Strategic Management at University of Salerno (Italy). Founder and Director of LISA Lab, a Research Centre focused on Technology transfer and the Entrepreneurial University. Visiting Student at Sloan Management School and Visiting Professor at George Washington University, Roberto has been recently appointed as President of the Group of researchers in Entrepreneurship by the National Academy of Management - SIMA. He served as a Co Chair in many Conferences and Global Forums promoted by ICSB and its affiliates, and has been nominated ICSB Global leader. He has co-founded several academic spin off companies working in the Biotech and Digital Health industry. Roberto's research interests are on entrepreneurship and sustainability.

ULLA HYTTI

Research Director, has over 20 years of experience researching entrepreneurship with a particular focus on entrepreneurship education and entrepreneurship at the individual level (entrepreneurial identity and careers). She has published her research in journals such as International Small Business Journal, Entrepreneurship & Regional Development and Journal of Rural Studies and has been the editor for many books and special issues. Ulla is currently the head of entrepreneurship section at the University of Turku, Finland. She is a Board Member in the European Council for Small Business (ECSB), and an Associate Editor in the Journal of Small Business Management since 2013. Ulla is the European Entrepreneurship Education Award Laureate from 2019.





MARKUS REIHLEN

is Vice President and Professor of Strategic Management at Leuphana University of Lüneburg as well as International Research Fellow at the Said Business School, University of Oxford. He is the author and co-editor of eight books and more than 60 journal articles and book chapters. His academic work has been recognized with eight Best Paper Awards from the Academy of Management, the Strategic Management Society, and the Academy of Marketing. Together with colleagues from Leuphana, he recently acquired a large research project on "Digital Entrepreneurship" from the European Regional Development Fund and the State of Lower Saxony.

KEYNOTE SPEAKERS

MARIO SORRENTINO

is Full Professor of Entrepreneurship at the University of Campania Luigi Vanvitelli, Italy, where he serves as Director of the Academic Lab for Entrepreneurship and Open Innovation and teaches Business planning & Venture Creation. His research interests include entrepreneurship, open innovation and technology transfer. He has published on Journal of Business Venturing and Technology Analysis and Strategic Management. He has been Visiting Scholar and Visiting Researcher at the Wharton School, University of Pennsylvania. Currently he is the Scientific Responsible of the Open innovation program on Millennials promoted by Fiat Chrysler Automobiles.



PAULA KYRÖ



Professor emerita, holds PhD degrees in both education and economics. She has worked as a professor in both fields in Finland and abroad. Her research groups Entre and Entre-Mileu were specialised in entrepreneurial learning processes and sustainable development. Kyrö has been nominated to diverse educational evaluation and development duties by different ministries in Finland and abroad. She has more than 90 publications as well as experience in managing nationals and international projects and collaboration networks. She also has extensive SME experience as a management consultant in her own company, Oy Startup Ab in the fields of strategic planning, organisational development and small business collaboration. Kyrö received an honorary award for meritorious consulting given by the Ministry of Trade and Industry and the SME Foundation in Finland. She has also received the third European Entrepreneurship Education Award in 2014.

AGNIESZKA KURCZEWSKA

is a researcher in the field of entrepreneurship and entrepreneurship education. She holds a postdoctoral degree in economics. Currently she has a position of an associate professor at the Faculty of Economics and Sociology at University of Lodz in Poland. She also holds a position of vice-dean, responsible for the Faculty's development. In 2010/2011 Agnieszka worked as an assistant professor in Entrepreneurship Unit at Aalto University in Helsinki. In 2014/2015 she spent 10 months at the University of Tampa (USA) conducting the research on academic entrepreneurship education. She was also a holder of the Polish Ministry of Science and Higher Education scholarship for the most talented young researchers. From 2015 Agnieszka Kurczewska is a member of the Board of Directors of the European Council for Small Business & Entrepreneurship (ECSB). She is also an associate editor in Journal of Small Business Management (JSBM). Her previous professional experiences include traineeships in European Commission in Brussels and Council of Europe in Strasbourg.



GUSTAV HÄGG

is a postdoctoral fellow at Sten K. Johnson Centre for Entrepreneurship, Lund University. He completed his PhD at Lund University in 2017, entitled "Experiential entrepreneurship education: Reflective thinking as a counterbalance to action for developing entrepreneurial knowledge". His research interest is focused on understanding knowledge development within entrepreneurship education and post education, currently studying how alumni students utilize entrepreneurial knowledge in their careers. But his research interest on entrepreneurship also span from philosophy, including critical and ethical perspectives guiding entrepreneurial behaviour towards the early start-up process.





ANTONELLA ZUCCHELLA

is Professor of Marketing at the University of Pavia. She is also Senior Research Scholar at Anglia Ruskin University, Cambridge. She is member of the Italian Academy of Business Economics, of the Academy of International Business Studies, of the European International Business Academy, of the American Marketing Association. She has authored several international publications on the themes of entrepreneurship, business internationalization and international marketing. Her latest volume "International Entrepreneurship", with Birgit Hagen and Manuel Serapio, published by Elgar in 2018, has been adopted in numerous International Entrepreneurship courses around the world.

SÍLVIA COSTA

is an Assistant Professor of Entrepreneurship at the University of Groningen, The Netherlands and collaborates in several research projects at the ISCTE-IUL, Instituto Universitário de Lisboa, Portugal. Sílvia was a Postdoctoral Research Associate at Northeastern University, Boston, U.S.A., where she was a grantee of the Kauffman Foundation on a project about entrepreneurial learning. Sílvia obtained a PhD degree in 2015, defending her doctoral thesis about entrepreneurial cognition at ISCTE-IUL, Lisbon, Portugal. For her PhD, Sílvia has collaborated with the University of Twente, The Netherlands, and with the Technical University of Dresden, Germany. Sílvia's research interests focus on entrepreneurial cognition and learning, with emphasis on the use of experimental designs. Her work has been published in the Journal of Small Business Management, Creativity and Innovation Management, International Journal of Entrepreneurial Behavior & Research, Journal of Social Entrepreneurship, Journal of Entrepreneurial Behavior & Co-authored several book chapters and books about entrepreneurship.
